Success in the position requires the recognition and understanding of relevant legal principles and restrictions, as well as the ability to understand, articulate, and incorporate strategic and tactical considerations which are consistent with and further the interests of JHHS and its tri-part mission.

Role Accountabilities Include

Providing legal advice and assistance in the identification, tracking, and trending of significant clinical issues regarding patient care, regulatory matters, ethics and other healthcare related matters.

Providing legal counsel to the committees of affiliate(s) including leadership reports as required by bylaws and policy.

Investigating adverse patient outcomes in anticipation of litigation and developing strategic and tactical positions and responses to proposed courses of action.

Researching and analyzing health care related legal issues and drafting legal memoranda.

Investigating and preparing responses to Maryland Department of Health complaints.

Meeting with State and other regulators, including TJC, during announced and unannounced site visits.

Managing and reporting events to state, federal and other regulatory bodies as necessary.

Attending State regulatory meetings regarding patient safety, quality and risk management.

Participating and advising during the Sentinel Events Group (SEG) meetings by creating and maintaining documentation for presentation to SEG Management, and Boards of Trustees.

Participates and advises on proactive risk assessments as required by TJC and Johns Hopkins policies.
